#### 2. Objective and Purpose

#### 3. Scope of CSR Policy

This Policy applies to all CSR projects that will be undertaken by BOIT and shall fulfil all the requirements of Section 135 of the Companies Act, 2013. BOIT shall ensure all these activities are over and above the normal course of business and are in line with Schedule VII of the Companies Act, 2013. This Policy will be periodically reviewed and updated in line with the relevant codes of legislation and best practices that can be adopted by BOIT.

#### 4. Areas to Emphasize

BOIT has broadly selected four areas of focus under its CSR activities, as under:

### Education & Skill Development:


- Promoting education, including special education and employment enhancing vocation skills especially among children, women, elderly, and the differently abled and livelihood enhancement projects.
- Providing scholarships, paying school fees or financial assistance needy students
- Providing financial Aid or equipments etc to Schools

### **Environment Sustainability:**

- Ensuring environmental sustainability ecological balance, protection of flora and fauna, animal welfare, agro forestry, conservation of natural resources and maintaining quality of soil, air and water;
- Protection of national heritage, art and culture including restoration of buildings and sites of historical importance and works of art; setting up public libraries; promotion and development of traditional arts and handicrafts

### Health care, Medical and other Welfare

- Providing medical relief and rehabilitation to communities who either don't have access to quality health care or cannot afford it;
- Providing financial assistance to Thalassemia patients.
- To give financial assistance to Hospitals, Local Authorities Municipalities, Urban Improvements Trusts and such other bodies for public utility & welfare.

- Promoting gender equality, empowering women, setting up homes and hostels for women and orphans, setting up old age homes, day care centers and such other facilities for senior citizens and measures for reducing inequalities faced by socially and economically backward groups;

- Slum area development.

## 5. Undertaking CSR activities

BOIT will undertake CSR activities either directly and/or through not for profit, registered trusts/societies/other body corporate who are engaged in activities or programs which fall within the purview of BOIT's CSR Policy and areas of focus and/or directly through a Section 8 Company which it may set up in future for the purpose.

## 6. CSR Committee

BOIT has constituted Corporate Social Responsibility Committee (the "CSR Committee") in line with Section 135 of the Companies Act, 2013 (the "Act"). The CSR Committee consists of following members of the Board:

The CSR Committee of the Board shall be responsible for:

- Review of CSR activities in the Company.
- Formulation of CSR Policy.
- Monitoring of implementation of CSR Policy.
- Recommend to the Board, modifications to CSR Policy as and when required.
- Appraise to the Board the CSR expenditure done during the year.

# 7. CSR Spend

The Company will endeavor to contribute and spend 2% of the average net profits of the Company made during the three immediately preceding financial years or such amount as may be recommended by the CSR Committee from time to time in pursuance of this Policy, whichever is higher. 'Net Profit' shall be calculated in the manner prescribed by the Act and the CSR Rules.

The CSR Committee shall propose to distribute the amount among the Areas to Emphasize or such of them as the CSR Committee may deem fit in each financial year, in such proportion and in a manner that meets the objectives of the CSR Policy.

#### 8. Compliance statement

The CSR policy of the company was approved by the company's Board of Directors on 18<sup>th</sup> December 2014 for adoption as the company's CSR policy. The contents of this policy shall be appropriately disclosed in the Board report in accordance with the requirements of the Companies Act, 2013, and rules framed there under.
